





Dr. K.Y. Ratnam (External Member), University of Hyderabad, Hyderabad couldn't attend and the following agendas were taken up:

Agenda 1: In the 2nd Year also, within four months, Mr. Bhagat Narayan Mahato was absent for 51 days.

Mr. Bhagat Narayan Mahato has been admitted provisionally to Ph. D., programme in Dalit and Tribal Studies on 30.11.2017. His enrollment no. is 2017/03/310/003. Student of Ph.D., programme is entitled to be absent for not more than 30 days in year as per Ph.D., rules clause no.14. In the first year (30.11.2017 to 29.11.2018) Mr. Bhagat Narayan Mahato was absent for 114 days. In the first year within 6 months he was absent for more than 30 days. The trend in the second year is worse than the first year. Within four months of second year (30.11.2018 to 09.04.2019) he was absent for 51 days. He is availing Non-NET Fellowship. As per Ph.D., Ordinance no. 45/2017, clause 14.1 (b) "if any research scholar avail more than 30 days of general leave, she/he shall be treated as absent for the excess period of leave of leave availed. In such cases BoS may grant 10 days of additional general leave on the application of research scholar recommended by the Supervisor, if the case seems genuine in its opinion. Beyond 10 days of excess general leave, no general leave shall be permitted in any case and the admission/registration of the research scholar shall be automatically cancelled." As per Clause 14.3.6 any kind of fellowship and Ph.D., admission of research scholar is liable to be cancelled for the excess period of absent.

Therefore Mr. Bhagat Narayan Mahto's admission was automatically cancelled under the clause 14.1 (b) of the Ph.D Ordinance. The same was approved by the Board of Studies of the Centre for Dalit and Tribal Studies in the 13th meeting held on 04.12.2018. The same was approved by the School Board of the School of Culture in the 16th meeting held on 05.12.2018 and the same was approved by the Academic Council of the University in the 29th meeting held on 04.3.2019. **However till the date the University has not yet notified the cancellation of his admission.**

Resolution: Mr. Bhagat Narayan Mahto was absent for 114 days in the first year. As he can't be absent more than 30 days, under the Ph.D., Ordinance no. 45/2017 (approved by the Academic Council on 17.7.2018), clause no.14.1 (b), his admission has been automatically cancelled. It was already approved by Board of Studies, School Board and Academic Council. And also within four months of the second year he has been absent for 51 days. Hence the cancellation of his admission is once again approved and recommended to the competent authority to initiate further action in this regard.

Agenda 2: Case of absent of Mr. Bhagat Narayan Mahto for presentation of Research proposal in Pre-Registration Seminar before Board of Studies of the Centre.

Mr. Bhagat Narayan Mahto was admitted provisionally to Ph. D., programme in Dalit and Tribal Studies on 30.11.2017. He was absent for presentation of Pre-Registration Seminar in the 11th meeting of Board of Studies held on 28.02.2018. Hence he has been given another chance to present his research proposal in pre-registration seminar before the 12th meeting of the Board of Studies. In the 12th meeting of Board of Studies held on 30.8.2018, he made presentation of his

research proposal for doing Ph.D., on the topic: "An Analytical study of the socio-cultural history of Tharu tribe" (With special reference to Trai area in north India)". It is observed that the proposed topic is more or less similar and simply an extension to his M.Phil topic, "A Historical and Cultural Study of Tharu Tribe: With special reference to west Champaran, Bihar". Identification of research problem and methodology proposed in his presentation is same as M.Phil and copied word to word from his M.Phil dissertation and presented in the Ph. D., research proposal. Bibliography of M.Phil dissertation is re-produced same as without addition of any new Hindi books/literature in Ph. D., research proposal. The presentation of research proposal is also not satisfactory as he couldn't provide satisfying answers to the questions on research problem, methodology and review of literature particularly for the questions raised by the external member. His proposal has no tentative chapterisation. In view of the above Dr. Rakesh Singh Phakaliyal under whom the research to be conducted is of the opinion to guide a different topic other than the proposed one. Therefore, Mr. Bhagat Narayan Mahto was given on humanitarian grounds another chance to present his research proposal in pre-registration seminar before the next meeting of the Board of Studies that is 13th meeting. And he shall in consultation with Dr. Rakesh Singh Phakaliyal make topic and area of research for preparation of the research proposal. However, he made no effort to consult his research advisor Dr. Rakesh Singh Phakaliyal. Hence he was reminded by the letter dated.08.1.2019. Mr. Mahato didn't make any communication to the Centre about his participation in the 13th meeting for Pre-Registration seminar. Hence the matter was not discussed in the 13th meeting. In the 14th meeting Dr. Rakesh Singh Phakaliyal informed to the BOS that Mr. Bhagat Narayan Mahato didn't consult him in this regard till the day before the 14th BOS meeting. He also didn't make any communication to the Centre about his participation to present Pre-Registration research proposal till 08.4.2019. On humanitarian grounds, he was so far given four chances (as per Ph.D rules clause no.16, only two chances are allowed). The matter is placed for discussion and approval.

Resolution: Mr. Bhagat Narayan Mahato was already given four chances on humanitarian grounds to present research proposal (synopsis). He never made any effort to consult his research advisor Dr. Rakesh Singh Phakaliyal for preparing his research proposal as directed by the Board of Studies. Hence, providing further opportunity even on humanitarian grounds is against the Ph. D., rules. Therefore, it is resolved unanimously to recommend for the action against Mr. Bhagat Narayan Mahato as per the University Ph.D., ordinance 45/2017, clause 14.3.3 & 16.

Agenda 3: Presentation of Research proposal in Pre-Registration Seminar before Board of Studies of the Centre by the following students: 1. Kesh Nath Prasad ; 2. Pallavi Morey; 3. Shrilekha Kumari; and 4. Aarti .

However he was absent for more than 30 days within the three months of his admission that is by 6th March 2018. Hence his admission was cancelled on 23.05.2018 by the Office Order no. 028/Ph.D/2017/DTS/13/721, dated.23.05.2018 enclosed here as ANNEXURE-I. However on humanitarian grounds under the principle of natural justice, the cancellation of his admission was withdrawn on 05.6.2018 by the Office Order no.028/Ph.D/2017/DTS/13/742, dated.05.06.2018 enclosed here as ANNEXURE-II. However, he continued to be a student of unauthorized absent. He has completed one year on 29.11.2018 from the date of his admission. Leave rules as per Ph.D., Ordinance no. 45/2017:

"14. LEAVE-

14.1 (a) A Ph.D. scholar may avail maximum 30 days of general leave (including medical leave) in a year, in addition to the general leave, academic leave for research field work, seminar, workshop, training programme etc. may also be granted based on the recommendation of the Supervisor concerned.

(b) If any research scholar avails more than 30 days of general leave, she/he shall be treated as absent for the excess period of leave availed. In such cases BoS may grant 10 days of additional general leave on the application of research scholar recommended by the Supervisor, if the case seems genuine in its opinion. Beyond 10 days of excess general leave, no general leave shall be permitted in any case and the admission/registration of the research scholar shall be automatically cancelled.

(c) In case, the supervisor is not allotted to a research scholar, all the applications of research scholar shall need to be recommended by the HoD/DoC.

14.3 Any Kind of fellowship and Ph.D. admission of research scholar is liable to be cancelled/legal action against the research scholar in the following cases:-

1. If the research scholar is found to be ineligible to be admitted to Ph.D. programme and to receive the fellowship, at any point of time during the entire duration of the programme and fellowship.
2. Misconduct of research scholar, such as proven defamation against supervisor concerned and other faculty and authorities of the University; complaint to higher authorities without routing through proper channel – HOD, DEAN and Vice Chancellor
3. Unsatisfactory progress of research work.
4. More than one fellowship or any other income is drawn simultaneously.
5. Concealment of facts and any other ground of misconduct.
6. As per clause 14.1 (b) of this Ordinance."

Mr. Bhagat Narayan Mahto was absent for total 124 days, out of which 94 days are un-authorized absent as he is not entitled for more than 30 days leave/absent in a year starting from the date of his admission. Hence, as per 14.1 (b) & 14.3.6 of Ph.D., Ordinance no. 45/2017, the admission of Mr. Bhagat Narayan Mahto in the Ph.D., programme has automatically been cancelled.

The matter is placed for consideration and approval.

Resolution: After the perusal of the records and thorough discussion, the following resolution is passed unanimously:

The period for which Mr. Bhagat Narayan Mahto's admission was cancelled, that was from 23.5.2018 to 05.6.2018 for 10 working days be treated as not absent. Hence, the total days of absent are 114 and the total days of unauthorised absent are 84 days. It is not simply a case of unauthorized absent. The student concerned is absent for near about three times more than the prescribed period of absent. It shows that the student is neither serious nor sincere in his academic pursuit. Under the principle of natural justice; on humanitarian ground, Mr. Bhagat Narayan Mahto was already given an opportunity. Since he is a habitual offender of the law, he deserves no further opportunity. Providing further opportunity to him discourages sincere students and vitiates the conducive academic atmosphere as it encourages students to break the law. Academic research requires serious and sincere scholars. On the same Ph.D., seat, any other serious academic scholar from the Scheduled Tribe category could be given an opportunity. As on date the admission of Mr. Bhagat Narayan Mahto in the Ph.D., programme has automatically been cancelled by the law that is 14.1 (b) & 14.3.6 of Ph.D., Ordinance no. 45/2017, which is also inconsonance with the UGC guidelines. Hence, in accordance with the rules, prescribed in the Ph.D., ordinance, the automatic cancellation of the provisional admission of Mr. Bhagat Narayan Mahto is approved.
